**PRODUCT LIMITED WARRANTY**

Shantou Institute of Ultrasonic Instruments (SIUI) aka, SIUI America, Inc. warrants to the original purchaser/customer of its products if purchased from an authorized SIUI Dealer that, should it prove defective by reason of improper workmanship and/or material:

1. Model CTS Ultrasound Equipment – For twenty-four (24) months from the date of original purchase, we will repair or replace, at our option, any defective part without charge for the parts and labor. Parts used for replacement are warranted for the remainder of the original warranty period.
2. Apogee 800 plus Ultrasound Equipment – For twelve months (12) from the date of original purchase, we will repair or replace, at our option, any defective part without charge for the parts and labor. Parts used for replacement are warranted for the remainder of the original warranty period.
3. Transducers/Probes –For twelve months (12) from the date of original purchase, we will repair or replace, at our option, any defective part without charge for the parts and labor. Parts used for replacement are warranted for the remainder of the original warranty period.
4. Notice. To obtain warranty service, you must notify an authorized SIUI service center of any defect within the applicable warranty time period.
5. To obtain warranty service, deliver your SIUI products to the designated SIUI authorized dealer or service center. Shipping to the authorized service center is the customer's responsibility. Proof of purchase date from an authorized SIUI dealer is required when requesting warranty service. Present your invoice or other document, which establishes proof and date of purchase.
6. This warranty does not cover damage caused by: accident, modification, alteration, repair or service of this product by anyone other than an authorized SIUI service center, physical abuse to, or misuse of, the SIUI product; operation in a manner contrary to the instructions which accompany the product package; freight damage; or any damage caused by acts of God such as lightning or fluctuation in electrical power. This warranty also excludes all cost arising from installation, adjustment of user controls, external systems, service of products purchased or serviced outside the U.S.A., initial technical adjustments (set-up) and user-required maintenance (if any). Consult the operating instructions enclosed with the product for information regarding user controls.
7. SIUI limits its obligations under any implied warranties under state laws to a period not to exceed the warranty period.
8. SIUI also excludes itself from any liability, whether based in contract or tort for incidental, consequential, indirect, special, or punitive damages of any kind, or for loss of revenue or profits, loss of business, loss of data, or other financial loss arising out of or in connection with the sale, installation, maintenance, use, performance, failure or interruption of this product.
9. This warranty gives you specific legal rights and you may also have other rights that vary from state to state.
10. Before requesting service, please review the instruction booklet to insure proper installation and correct customer control adjustment. If the problem persists, contact Exodus Breeders Corporation; your original SIUI Dealer and they will direct where the ultrasound is to be sent for examination and repair.
